friars Cove Pool Rules

2018

- -Each family is allowed up to five free guests each day they use the pool. If you have additional guests you must pay the guard \$5.00 per person beyond the 5 free guests. We will **NOT** be using guest passes. Each family will be on their honor to report additional guests to the guard on duty and pay for the guests. This means 5 free guests per day total-(not 5 were here, 2 left 1 more came....5 total throughout the day. Please be honest and just turn the money in to the guard on duty). **As a courtesy to your neighbors and for the safety of all patrons, you MUST inform our pool manager Christina Capuani** @ **630.819.9671 a minimum of 24 hours ahead of time of your plans to have 5 or more guests at any time so lifeguards can be scheduled accordingly.** When hosting a party, please be courteous to the members. The guards can set up your party on the upper deck of the Lodge if it is available. You can set up tables in the park....just please do not set up camp on our small food deck for the day and take this area away from the other members. You can arrange all of this with the pool manager prior to your party.
- -Members renting the Lodge (**NOT MEMBER SPONSORED RENTALS**) are allowed to use the pool. The member is required to pre-arrange the pool usage through the pool manager and pay for all guests in excess of 5. The total number of guests must be submitted and paid for prior to usage. The Member must be on Lodge grounds while the guests are using the pool. Failure to clear the party with the pool manager can prohibit your use of the pool if we cannot adequately staff as a result.
- -The pool staff has the right to refuse admission, or to dismiss from the pool, any guest unaccompanied by a member or any person who endangers the safety of others in the pool area.
- -Footwear of any kind is not allowed on the pool deck. Please remove your shoes prior to entering the pool area.
- -All food must be kept up on the wooden deck and is not allowed on the pool deck. All drinks **MUST** be in metal or plastic containers. **ABSOLUTELY NO GLASS** is allowed anywhere in the pool or deck area!!!

- -There is absolutely **NO SMOKING** allowed anywhere in the pool area, decks or cement deck just outside the gate. Smoking must be at least 15 ft from the pool gate. It is a common courtesy to all those using our pool, especially children running around in bare feet, to not have smokers within 15 feet of our pool gates. And please, if you do choose to smoke in our parking lot, clean up after yourself.
- -Life jackets and plastic inflatable pool toys are allowed in the shallow end of the pool only. A responsible adult must be in the pool within arms reach of non-swimmers, including those with life jackets or flotation related devices.
- -All swimmers must wear a swimsuit. Exception: clean white t-shirt to protect from sun.
- -Soap showers must be taken before entering the pool-especially children coming back and forth from the park.
- -Members are responsible for any damage, accidental or otherwise, to Lodge property caused by themselves or their quests.
- -Adult swim/guard breaks will take place 10 minutes prior to each hour (i.e. 1:50, 2:50...) every hour at the discretion of the lifeguard on duty. Children under the age of 18 are not allowed in the pool during these breaks. This includes the step area of the pool.
- -Any child under the age of 10 must be accompanied by a person who is at least 13 years of age who is responsible for the child at all times. Exceptions can be authorized by the pool manager after the child passes a swim test and is deemed able to obey the pool rules.
- -Pool hours will be posted. Generally the following will apply

Open Swim Daily 11:00 AM-9:00 PM

*pool may close early later in the season if there is no demand for use

The pool may be closed for the following reasons;

*temperature below 70 degrees

*severe weather (i.e.) thunder and lightening

*damage to the pool and or area that may pose a safety or health risk

*lack of attendance in which case an adult homeowner can call one of the board members to obtain keys and use the pool with the following restrictions:

Adult homeowners may use the pool with their own children during this time. Adult homeowners may also use the pool at this time with a maximum of **TWO ADULT** guests. The **HOMEOWNER MUST BE PRESENT THE ENTIRE TIME** and is responsible for cleaning and locking the facility. An adult child of the resident is **NOT** the homeowner and therefore cannot be there with guests. Children under the age of 18 must have a responsible adult supervising them at all times. Fence hopping is **NEVER** permitted. Please be sensitive to those who live near the pool so they do not have to deal with excessive noise late at night.

We, of course, hope to have the pool staffed during all operating hours. In the event a lifeguard is not available or you encounter a sign at the pool stating **NO LIFEGUARD ON DUTY**, the same rules as above apply. Adult homeowners may use the pool at this time with a maximum of **TWO ADULT** guests. The **HOMEOWNER MUST BE PRESENT THE ENTIRE TIME** and is responsible for cleaning and locking the facility. An adult child of the resident is **NOT** the homeowner and therefore cannot be there with guests. Children under the age of 18 must have a responsible adult supervising them at all times. If you, as the adult on deck, notices an unsupervised child, please ask them to leave (they can run home and get their parent). If you are the last adult left and you are leaving the pool area, please lock the gate. Fence hopping is **NEVER** permitted.
